

# *St. Rose of Lima School*

## *Tuition Policy 2020-2021*

St. Rose of Lima tuition is set to cover approximately 75% of the operating budget of the school and its programs. The remaining 25% is generated through development and fundraising at 10% and parish subsidy at 15%. It is essential that our families understand and accept the commitment for prompt payment of tuition for the successful management of the school and the budget. The following policy and procedures are effective for the 2020-21 school year. **The increase for tuition for the 2020-2021 is \$130 per first child.**

**Registration Fee:** Every family is required to pay a **\$110 per child non-refundable registration fee** each year. This fee saves a seat for your child for the next school year and covers the cost of the RenWeb, Standardized Testing, and Diocesan/Professional Fees each year. This fee **MUST** accompany the registration forms due by **March 31, 2020.**

### Payment Plans:

- ▶ **Payment Plan A ( No Fee)**
  - **One Full Payment** due by August 1, 2020 (May be paid directly to School or through FACTS)
- ▶ **Payment Plan B (\$10 Fee):**
  - **Two - Bi-Annual Payments** August 2020 and January 2021.
- ▶ **Payment Plan C (\$44 Fee):**
  - **Four - Quarterly Payments** beginning in August, 2020, November, 2020, February, 2021, and May 2021.
- ▶ **Payment Plan D ( \$44 Fee):**
  - **Ten - Monthly Payments** beginning in August 2020 and ending in May 2021.

The fees (\$10 / \$44) will be assessed from your accounts in May of 2020.

**Failure to comply with the policy may result in your child's dismissal from the school.**

**Pre-School ~ Registration must be done on a separate payment form. The fee (\$10/\$44) on the pre-school form will be waived if you have children in the Elementary School.**
